## THE OPPORTUNITY

The Benefits for Success CTE Academy is a one-year hands-on learning and design program for community college CTE programs to **maximize students' use of vital benefits, resources, and supports**. Designed to build on existing work at the college, the Academy will provide participants with new strategies to support student retention and completion goals through the design and testing of evidence-based solutions.

Participating colleges will develop resilient practices to support student success and respond in real time to COVID-related challenges. Participants will receive training in improvement science, allowing them to lead the way in developing innovative processes that streamline benefits access for students. By the end of the Academy, participants will have gained:

- New and enhanced strategies to support student retention and completion goals
- A deeper understanding of the current student experience: obstacles that students encounter, their needs and motivations, and their ideas for improvement
- A stronger understanding of how students engage with benefits, resources, and supports
- Experience using applied behavioral science, improvement science, and human-centered design techniques
- Results from intervention testing to remove obstacles in student-facing processes
- The capacity to address similar challenges in the future and support more students in need

## ADDRESSING STUDENT NEED

**Overview:** During this pandemic, students are struggling to stay enrolled in college. COVID-19 hits low-income and underserved students the hardest—the very students who could benefit most from a post-secondary education.

A key solution is to ensure that **students take full advantage of the benefits and supports available to them**. In this Academy, SCD will work with colleges to make sure that resources for students don't go under-utilized. Maximizing students' use of resources will help colleges make lasting changes to the ways they deliver services to **meet current and future challenges**.

1. Why is your college interested in participating in the **2021 Benefits for Success CTE Academy**?
2. Please identify a benefit or resource that will be your college's area of focus for this Academy. You will be developing solutions to improve student access to and/or usage of this benefit or resource. Consider choosing a resource that is:
  - Under-accessed
  - Under-utilized
  - Could substantially alleviate student need
  - Could benefit from updates or improvements

(Examples include but are not limited to: food security resources such as SNAP or food pantries, physical or mental health resources, financial supports, tutoring or other academic supports, technology support, state or local-level public assistance benefits, SNAP E&T or workforce funding, other wraparound services.)

3. Please describe why you have chosen this particular benefit, resource, or support for your area of focus. Why is it a good fit for this Academy?
4. Explain how this benefit or resource targets an area of need for your students. Provide data or evidence, if possible.

(For example: Students could benefit from a workforce funding grant program available at the college. Data indicates that a sizeable percentage of students have unmet financial need and could qualify for the program. However, students are unaware that this program exists, or are confused about how to access it.)

5. Based on your understanding, what do you believe are the main reasons that students are under-utilizing this benefit or resource?
  - If applicable, how are you changing (or considering changing) the way you deliver this benefit or resource to students to address the reasons described above, or to better address student needs?
6. If you are selected to participate in this Academy, will your college president sign a statement of commitment to signal support for this work?
7. Please list information about your proposed project team. You do not need to have every project team member selected at this stage, but you DO need to designate a **Project Lead** and a **Leadership Team Member**. [Application form includes a table to fill out.]
8. How did you (or your college) hear about the 2021 Benefits for Success CTE Academy?

## BUILDING A PROJECT TEAM

Participating colleges will bring a team of 3-4 staff/ faculty members to the Academy.

**You do not need to have every project team member selected at this stage, but you DO need to designate a Project Lead and a Leadership Team Member.**

To help you select these two team members, and to help you begin thinking about the other members of your project team, please see the considerations below.

### Considerations for Selecting Project Team Members

Team members should include:

- A staff member who oversees, is familiar with, or directly connects students to the benefit, resource, or support that will be the college's key area of focus for the Academy (for example, Career Pathways staff member, financial aid advisor, student services staff member, etc.)
- A project sponsor who is a member of or has a direct line to the college's leadership (for example, Vice President of Student Affairs, Executive Dean of Workforce, etc.)
- A staff or faculty member in CTE (for example, CTE director, department chair, CTE student advisor, etc.)

## THE PROJECT TEAM LEAD

Any of the project team members can be the Project Team Lead. The Lead should plan to allocate 6-9 hours per month to the Academy. The Lead will serve as the liaison between the SCD team and the college. They will also work to ensure that project and intervention implementation move forward.

The Project Team Lead should have:

- Knowledge of and involvement in current campus initiatives and strategy
- A high-level understanding of how the college allocates its institutional resources, as well as resource constraints and possibilities
- The ability to keep this project moving forward, particularly during the intervention development and implementation phase

## THE LEADERSHIP TEAM MEMBER

The Leadership Team Member should be able to “sponsor” the project work and ensure that the team has the institutional support necessary to move the work forward.

The Leadership Team Member should have:

- A vision for how this work connects to the college’s mission and strategic plan
- Executive authority to implement interventions and integrate them into practice

## OTHER PROJECT TEAM MEMBERS

Project team member(s) from CTE should:

- Work primarily with CTE programs and be familiar with the CTE student body
- Be able to help assess CTE student needs and integrate intervention design and implementation into CTE processes

Project team member(s) connected to the specific benefit or resource (key area of focus) should:

- Be familiar with the processes that connect and/ or enroll students in that benefit or resource and be able to provide that context to other project team members
- Be able to help implement and test interventions or process improvements

Project team members who are not the Lead should expect to dedicate about 3-6 hours per month.
